

BeltLine Park & Trail Grand Opening in West End This Saturday Featuring Our Members

YOUR PARTICIPATION IS NEEDED

The West End Church of Christ will be playing a prominent role this Saturday during the opening of the West End section of Atlanta's Beltline Park and Trail System. The first section of the BeltLine trail system is opening in Historic West End. Connecting Rose Circle Park to Brown Middle School and a completely renovated Gordon White Park, the trail is already improving mobility for local residents. Phase II - to be completed early next year - will wind through the Westview neighborhood out to Westview Cemetery. At this event, slated to begin at 8:30 a.m., the Mayor of Atlanta, city officials, the news media, and celebrities will be on hand at the park adjacent to Dunkin Donuts for a ribbon cutting, 5K run and opening ceremonies.

Our congregation will be taking part in the festivities. The organizers are promoting us as the location for free parking and a support of the project in the community. **Orpheus Heyward is on the program to deliver the opening prayer at 10 a.m. followed by a song selection by the West End Youth Chorus.** We will have a table set up to promote West End's services, our ministries and more.
